Indian Economy Update

India's economy in July 2025 continues to demonstrate encouraging resilience and forward momentum, despite ongoing global uncertainties. As we move through the Second quarter of FY 2025-26, several macroeconomic indicators reflect a stable economic environment and growing confidence across sectors.

Inflation remains under control, manufacturing activity is gaining strength, and government-led capital expenditure is fuelling growth. Sustaining this momentum will require a continued focus on inclusive labour policies, global trade integration, and improvements in domestic productivity. Structural reforms and enhanced infrastructure investments will further strengthen India's economic foundation and competitiveness.

A recent report highlighted the significant contribution of digital platforms to India's economy. In 2024, Google Play and Android ecosystems alone are estimated to have generated over ₹4 lakh crore in revenue for app publishers and the wider Indian economy. The report underscores India's thriving digital economy driven by affordable data, wide smartphone usage, and a vibrant entrepreneurial ecosystem. It also reveals that these platforms supported over 35 lakh jobs directly and indirectly, with more than 10 lakh jobs created in app development. India now ranks second globally in the number of registered developers on Google Play.

While the outlook remains positive, certain critical areas demand focused attention:

- Increasing female participation in the manufacturing workforce
- Enhancing the effectiveness of industrial incentive schemes (such as PLI)
- Speeding up trade agreements and addressing policy bottlenecks

With low inflation, a stable growth trajectory, and proactive policy support, India's economic landscape remains promising.







By embracing simplicity, individuals can focus on what genuinely nourishes them—be it relationships, passions, or personal growth. This lesson teaches that living simply is an active choice to prioritize well-being over societal expectations, allowing for a life rich in meaning and purpose.

2. Mindful Consumption

Humble encourages readers to engage in mindful consumption by critically evaluating their purchases. This means asking questions like: "Do I really need this?", "What is its impact on the environment?", and "How does it align with my values?". By reducing material consumption and opting for sustainable products, individuals can lessen their environmental footprint and foster a lifestyle that reflects their ethical beliefs. This awareness can lead to more intentional choices and greater satisfaction in what one does choose to own.

3. Connecting with Nature

Throughout her journey, Humble emphasizes the healing power of nature. She shares personal anecdotes about how spending time outdoors—whether through gardening, hiking, or simply observing wildlife—provides a sense of peace and grounding. Nature encourages mindfulness and presence, helping to alleviate anxiety and promote happiness. This lesson teaches that by integrating regular outdoor experiences into daily life, individuals can cultivate a more balanced and fulfilled existence.

4. The Power of Community

Humble highlights the importance of building a strong community network. She reflects on how shared experiences and mutual support can enhance resilience during challenging times. By actively participating in community events, volunteering, or simply connecting with neighbours, individuals can foster relationships that create a sense of belonging. This lesson illustrates that

no one is alone in their journey; community can provide emotional support, practical help, and shared joy that enrich life's experiences.

5. The Joy of Cooking

Cooking is portrayed as both a creative outlet and a way to connect with loved ones. Humble discusses her journey to rediscover the joy in preparing meals with fresh, local ingredients. 

A framework for emotionally intelligent leadership

Cultivate awareness, transformation, and mindfulness for well-being in organisations

n today's high-octane corporate world, anxiety has become an invisible currency we trade daily - silently depleting our emotional reserves. The rise of artificial intelligence has intensified fears of redundancy, pushing some people further into isolation, with Al becoming their closest companion at work and home. The only true antidote? Cultivating a genuine, lived, and acknowledged culture of caring and sharing.



Because she felt seen and heard, not merely supervised.

Deadlines pile up. Inboxes overflow. Expectations skyrocket as data is now available much more easily to many more. Yet leadership today isn't merely about driving results - it's about raising collective consciousness. It's about empathy, navigating hard conversations, embracing healthy conflict, and creating safe spaces for ideas that dare to challenge the status quo-even when those ideas come from the rebels in the room.

But what if accessing peace, purpose, and perspective was as easy as withdrawing cash from an ATM? ATM (awareness, transformation, and mindfulness) for humaneness is a leadership framework cultivated over years of coaching CXOs, entrepreneurs, and family business owners. This is about fundamentally recalibrating how we lead and live. What leaders reward and punish matters deeply, setting the tone for organisational culture. Being humane in adversity isn't easy, yet when approached with a "no-choice" mindset, solutions emerge naturally, emphasising objectivity and coexistence as the way forward.

A young manager, a mother, once arrived at a meeting visibly distressed. The leader compassionately told her to go home and care for her sick child. No guilt, no drama - just empathy in action. Days later, she took charge of a stalled project and delivered stellar results. Why?

This leader established a flexible backup plan, recognising individual urgent needs. No one-size-fits-all-just empathetic awareness in action.

Once you cultivate awareness, transformation becomes the next step not merely of systems or KPIs, but mindset shifts: reframing stress as a signal, not a weakness; choosing empathy over ego; welcoming dissent as an innovation driver; and creating safe spaces for authenticity.

Transformation often occurs in micro-moments.

A CEO I coached once told her team, "I don't have all the answers what do you think?" Rather than surrendering authority, she invited collective intelligence. Her vision was clear: performance must walk hand-in-hand with well-being. Her mantra? "I want this and that too." Not either-or, but both.

Mindfulness is the inner charging station. It doesn't require extensive meditation.

Sometimes, mindfulness is: 10 focused minutes before critical meetings; journaling after tough conversations; regular alignment with personal purpose and values; and rituals like gratitude circles or mindful breaks.

IMPACT OF BUDGETED TAX RELIEFS, SURGE IN REFUNDS Direct tax mop-up dips 1.3% this fiscal

New Delhi, July 11

THE CENTRE'S DIRECT tax collections after refunds fell by 1.3% to 15.63 lakh crore till July 10 of the current fiscal, reflecting impact of budgeted tax reliefs and a surge in refunds.

The collections are trailing the pace needed to meet the ambitious FY26 direct tax tar-get of ₹25.2 lakh crore, which represents a 13.2% annual growth. This, despite the significant income-tax reliefs announced in the Budget. Corporate tax receipts (postdefund) declined by 3.7% on year to 2 lakh crore as of July 10 of 2025-26.

Non-corporate tax receipts, excluding the securities trans-action tax, saw flat growth at 23.4 lakh crore during the period.

In the FY26 Budget, the Centre sharply raised the incometax exemption limit under the new tax regime was raised sharply to 12 lakh from 7 lakh, alongside a reduction in tax rates across income slabs.

These changes are expected to leave an additional 1 lakh



Company Registrations Increase 8.3% in June, LLPs Jump 18.4%

Banikinkar Pattanayak

New Delhi: Fresh registrations of companies rose 8.3% in June from a year be-fore and those of limited liability partnerships (LLPs) jumped 18.4%, as investors continued to bet on India's strong longer-term economic growth and consumption outlook.

As many as 16,654 companies, including overseas entities, were incorporated in June, against 15,375 a year earlier, showed the latest corporate affairs ministry data.

With this, company registrations rose for a sixth straight month through June. However, the pace of increase in

incorporations in June eased from 29% in May and almost 50% in April, which were, of course, aided by a favourable base effect.

The data showed the number of companies that got incorporated in the June quarter jumped 29% from a year



before to 61,141.

The number of new LLPs that got registered in June stood at 7,534, against 6,362 a year earlier. In the June quarter, 23,068 LLPs got registered, up over 30% from a year before.




Services to lead consumption spends

INDIA'S CONSUMPTION EXPENDITURE in the current fiscal will be led largely by consumer services such as telecom, travel and tourism, food and medical services rather than spends on consumer goods, according to a new report by Jefferies. It has taken 47 firms, including those in consumer goods and services, to arrive at the analysis. The growth in consumer services spends (reflected in revenue growth of firms within the universe) is estimated at 19% this fiscal versus expenditure on consumer goods, (13%). While this is 200 bps higher than FY25, expenditure on consumer services has been stable at 19% in the last two years.



New National Co-Op policy aims to cover 500 mn people



he Centre on Thursday unveiled a new National Cooperative Policy, the first since 2002, which calls for creating a task force to bring 500 million people under the ambit of cooperatives, up from the 300 million. It also aims to ensure autonomous functioning and democratic member control of cooperatives.

The policy, which seeks to triple the sector's contribution to the Indian economy over the next 10 years, also proposes raising the number of cooperative societies by 30 per cent from the current 830,000.

Releasing the policy, Union Minister for Cooperation Amit Shah said a key objective was to ensure that every village has at least one functional cooperative, while each tehsil in the country should have at least five model cooperative villages. The policy also calls for free and fair elections of the Board of Directors and office bearers of cooperatives.

While there is no direct data on the share of cooperatives in India's total gross domestic product (GDP), sector-wise figures indicate they accounted for around 14 per cent of total agricultural credit, 25 per cent of fertiliser production, 31 percent of sugar output, 85 per cent of liquid milk distribution, and around 15 per cent of total storage capacity in the country.

The policy was framed by a panel of experts chaired by former Union Minister Suresh Prabhu. Its implementation will be monitored

at the national level through a two-tier mechanism, chaired by Amit Shah himself.

Among other recommendations, the policy seeks to encourage branding of organic, agricultural, and dairy products under the 'Bharat' Brand as an umbrella brand, while also leveraging the established brands of individual states.

It also proposes the creation of a 'Cooperative Stack', a digital framework for data-driven decision-making and improved service delivery.

The policy calls upon Primary Agricultural Cooperative Societies (PACS) to work as 'Bank Mitras' of district cooperative banks to provide banking products and services directly to members at their doorsteps.

Manufacturing PMI Climbs to 17-Yr High of 59.2 in July

nternational orders surged to their strongest level since the series began India's private sector activity remained strong in July, maintaining a reading above the 60 mark for the second consecutive month, with the manufacturing sector recording its highest level in 17 years, growing faster than services, according to a private **şықү**еу.

The HSBC Flash India Composite Output Index was at 60.7 in July, slight-ly lower than 61 in June. The Composite Purchasing Managers Index (PMI) is a

weighted average of comparable manufacturing and services indices.

"India's flash composite PMI remained healthy in July. The strong performance was bolstered by growth in total sales, export orders, and output levels," said Pranjul Bhandari, chief India economist at HSBC.

Manufacturing PMI climbed to 59.2, its highest level in around 17 years, "indicative of a robust improvement in the health of the

manufacturing industry", the survey mentioned. Goods producers experienced a faster rise in output compared to service providers.

A cocktail of marketing wisdom

Marketing Mixology is a treasure trove of knowledge and a sparkling read, bringing together the right marketing ingredients

hat are the essential ingredients for marketing success? What are the key skills that marketers should possess? Are there simple, practical methods to learn and master these skills? What are the common pitfalls that marketers should avoid?

Ambi Parameswaran's new book Marketing Mixology attempts to provide a simple guide to all these questions. Ambi is one of the finest marketing minds I have known, and in this book, he draws on his extensive experience, spanning 45 years, to deliver a treasure trove of knowledge for every marketer.

A great cocktail firstly requires all the right ingredients. Thereafter, it also requires a superb bartender who knows these ingredients well, and can bring them together beautifully to create the magic. In keeping with these time-tested principles of mixology, Ambi first introduces us to four key elements which go into a successful marketing cocktail-understanding consumers, brand building, selling and negotiation and communication skills. Then, he provides us practical wisdom on how we can understand what makes these elements really tick.

Take, for instance, the art of understanding consumers. Ambi breaks down this art into many questions Who is the customer? How does the customer buy? What goes through the customer's mind? He then takes us through various well established research methods which can help us answer these questions, and thus inform our marketing actions.

Along the way, he cautions us that consumer behaviour studies cannot be similar across categories, because, as he points out, "buying a pack of potato chips is not the same as buying a car or a smartphone." You may think that this is obvious, but Ambi is right in striking this note of caution, because even experienced marketers often fall into the trap of thinking that some insights are universal.

Similarly, as Ambi walks us through the process of building brands, he begins by shattering some common myths, as he explains how brand building is not necessarily expensive, nor is it complicated, nor is it restricted only to the large companies of our world. He then puts forward a lovely framework of branding that can be used both by local entrepreneurs and established firms. I found this five step process, which Ambi calls the "Pentagon", to be very simple and powerful.


PENTAGON MODEL

The introduction to such memorable frameworks is one of the best parts of this book. The Pentagon model of brand building, the SPANCO model of selling, the six Ms of integrated marketing communication - they all come to life in these pages through Ambi's lucid explanation. These frameworks are very useful guides, because they help ensure a systematic approach to each of these disciplines. These models are accompanied by lovely storytelling, which help illustrate some of the key steps inherent these frameworks. What makes these stories particularly valuable is that so many of them are born out of Ambi's own experience. Hence, they are real-life narrations which resonate greatly. I think every practitioner of marketing will find these stories interesting and insightful.

Over the years, I have developed a fondness for books that can be read easily and at a single sitting. Marketing Mixology meets both these criteria. Ambi writes in simple language that is easy to understand, and the book flows fluently from cover to cover. In addition, this is a slim volume, only 152 pages long. A first reading took me not more than two hours. Thereafter, I have indexed some pages which I think will be particularly useful to me, and I plan to re-read these pages at leisure, in the days ahead.

There are some areas which I wish had received better coverage in the book. One of these is the art of pricing, which has always been key to marketing success, but is now growing further in importance and complexity, particularly given the advent of new sales channels such as modern trade, e-commerce and quick commerce. I feel that Ambi could have devoted some space to discussing the techniques of pricing, as well as the strategies and trade-offs that are integral to this area.

I strongly recommend the book to every marketer, and every reader who has interest in the art of marketing.

Similarly, regarding output, manufacturers saw a sharper increase in new orders than the service sector, with growth accelerating in the former but easing in the latter.

Overall, sales expanded at their quickest pace in a year.

"Indian manufacturers led the way, recording faster rates of expansion than services for all of the three metrics sales, output and export orders," said Bhandari.

International orders surged to their strongest level since the series began, the survey noted, driven by demand from across the world, including Asia, Europe and US. "Growth of new export orders accelerated in the service economy, whilst it slowed among goods producers," it added.

However, job creation slowed in July, marking the weakest employment growth in 15 months, with a notable slowdown in the services sector. Mean-while, inflationary pressures continue to heat up as both input costs and out-put charges rose in July, said Bhandari.

According to the firms surveyed, prices rose in aluminium, cotton, food-stuffs (cooking oil, egg, meat, vegetables), rubber, steel and transportation. Service firms faced a steeper rise in in-put costs compared to manufacturers.

"Charge inflation likewise intensified in July, as private sector companies sought to share additional cost burdens with their clients by lifting selling prices," it added.


Business sentiment, meanwhile, drop-ped to its lowest level since March 2023, though firms remained optimistic about output growth in the next 12 months. "Finally, business confidence fell to its lowest mark since March 2023, while employment growth moderated to its weakest pace in 15 months," said Bhandari.


